- 1. Summer Storage or Dockage Period or Summer Season ("Summer Storage") means the period of time during which boats, trailers and/or personal watercraft can be stored at Greater Wildwood Yacht Club ("GWYC") on land, rack, indoors or docked in the water. Summer Storage does not indicate, in any event, any other time or term of the calendar year. Summer Storage period is determined by GWYC and the Dockmaster each year and may be changed due to weather, availability of personnel and/or equipment or other condition.
- 2. Summer Storage Agreement or Slip Storage Agreement ("Agreement") means the contract entered into by and between the Boat and/or Personal Water Craft Owner ("Owner") and GWYC for purposes of Summer Storage.
- 3. Owner Obligations: Owner shall tender annually to GWYC the dollar amount indicated on the Statement of Dues and Fees in exchange for Summer Storage and/or other related services upon the signing of the Agreement in conformity with paragraph 4 herein. Signed Agreement will remain on file and will automatically renew for subsequent periods of the same length as the initial Summer Storage period.

Owner is responsible for carrying and maintaining its own property damage and liability insurance and GWYC will not be held liable for loss or damage of any kind to boats, motors, trailers and/or personal water craft or to any contents, gear or equipment left in or part of the same, from any cause whatsoever, including fire, theft, flood, windstorm, hurricane or other condition. However, in case of emergency, GWYC reserves the right to take any necessary precautions at Owner's expense for the protection of its own and other boats, trailers and personal water craft on yacht club premises, and shall not be liable for loss or damage or for personal injury resulting from the precautionary measures taken.

Owner hereby gives GWYC permission to enter and move boat, trailer and/or personal water craft in the event of impending hazard but shall not hold GWYC liable for damage resulting from either moving or not moving the boat, trailer and/or personal water craft. Owner agrees to have an automatic bilge pump on the boat. In the event of an emergency or circumstances that may require immediate action the GWYC may enter Owner's boat to do anything it deems necessary in its sole discretion to prevent damage to the Owner's boat or the yacht club premises. Such actions on the part of GWYC are only voluntary and not obligatory. Any charges incurred by GWYC to carry out the provisions of this paragraph shall be billed to Owner.

GWYC reserves the right to temporarily maneuver, rig, haul and/or reposition Owner's boat, trailer or personal water craft in order to perform ordinary or exceptional maintenance or construction on yacht club docks, pilings or property and shall not be held liable for any damages resulting to Owner's boat, trailer or personal water craft or to any of the latter's appurtenances, equipment or gear.

Owner is responsible for any damage its boat, trailer and/or personal water craft may cause to structures, pilings and other boats, trailers and/or personal water craft on the yacht club premises. GWYC shall have a lien against the designated boats, trailers and/or personal water craft, appurtenances and contents for any unpaid sums for damage to any structure, property or person at the Club. If action is necessary to enforce this lien, or to collect any amount due under this agreement, or for any repairs, services or purchases, the Owner and the boat, trailer and/or personal water craft shall have an additional liability for reasonable attorney's fees and cost of suit.

Owner shall not use toilet overboard discharge on the boat while in the lagoon or moored at a dock.

Owner is responsible for providing adequate lines where needed and regularly inspecting them for adjustment or replacement.

4. Payment: Upon signing of the Agreement, Owner shall tender to GWYC full or partial payment for the assessed Membership dues and Dock fees as indicated on the Statement of Dues and Fees. No boat, personal water craft or trailer may be launched, docked or stored on GWYC premises until all dues and fees have been paid in full and signed Agreement is on file.

GWYC may terminate this Agreement in its sole discretion if Owner or its affiliates breaches any of the covenants of this Agreement or violates any of the rules and regulations of the Club.
